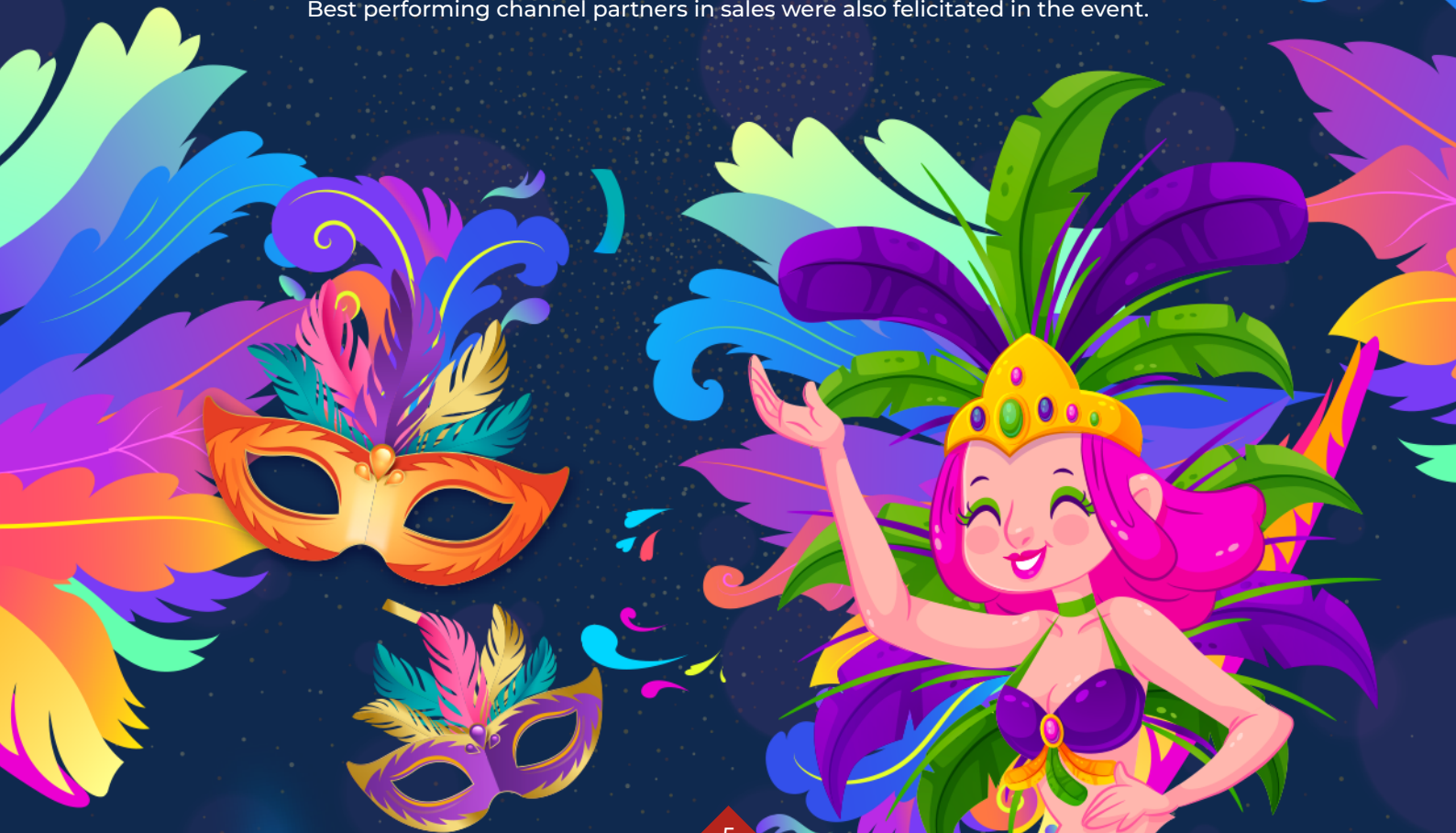



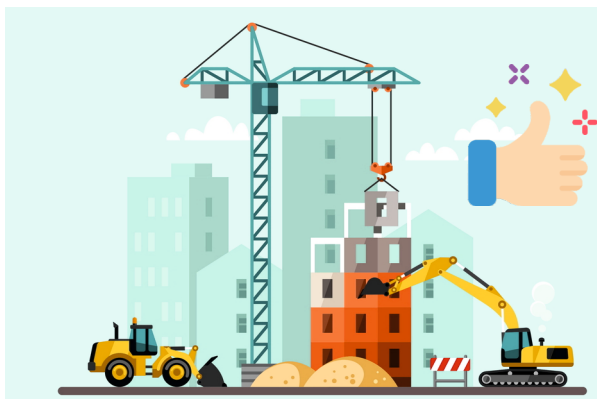

AMC DRAWS UP A PLAN TO REVAMP SARDAR VALLABHBHAI PATEL STADIUM



FAREWELL TO A LANDMARK: Ahmedabad's Sardar Vallabhbhai Patel Stadium, Designed by Charles Correa, Faces Demolition

Ahmedabad, a city steeped in history and architectural brilliance, is on the verge of bidding farewell to one of its iconic landmarks—the Sardar Vallabhbhai Patel Stadium. Designed by the legendary architect Charles Correa, this stadium has stood as a testament to modern design principles blended with cultural significance. However, the imminent demolition of this structure has sparked debates on urban preservation, the legacy of architectural icons, and the ever-changing cityscape.

A LEGACY IN CONCRETE:

Designed by the visionary architect Charles Correa, Sardar Vallabhbhai Patel Stadium, popularly known as Sardar Vallabhbhai Patel Sports Complex, was inaugurated in 1982. A GREEN REVOLUTION TAKEOVER

The real estate industry consumes a greater amount of energy than any other sector, accounting for nearly 40 per cent of the total emissions, and constitutes a burgeoning source of carbon dioxide emissions. Undoubtedly, the real estate sector, today, stands at a pivotal juncture where the incorporation of sustainable practices has evolved from not just merely being optional but a necessity. Green certified office buildings have almost doubled since 2016 to an impressive 421 mn sq ft, forming over 60 per cent of India's Grade A office stock. This underscores the increasing dedication of developers and occupiers to sustainability. Such commitment is anticipated to translate into advantageous pricing and asset valuation, leading to heightened brand value, enhanced client retention, and increased rental potential.

In alignment with eco-friendly living, our project Sanghvi S3 Ecocity, situated in Mira Road, Maharashtra, integrates sustainable initiatives into its design. These encompass rainwater harvesting systems, solar panels for enhanced energy efficiency, and effective waste management practices. There is great emphasis to green spaces within the project and it is just the perfect blend of greenery, luxury, tranquility, with uninterrupted hill view. These initiatives reflect a dedicated commitment to environmental responsibility.

The Mumbai Metropolitan Region Development Authority (MMRDA) has signed a Memorandum of Understanding (MoU) during the World Economic Forum in Davos in 2024 to enforce sustainable urban development in the Mumbai Metropolitan Region (MMR). The five-year collaboration guaranteed by the joint declaration will enable the Dutch financial and professional contributions. It comprises exchanging best practices for integrated waste management and smart city master planning.



The government has implemented numerous measures to encourage sustainable development, notably through the introduction of initiatives like the Green Rating for Integrated Habitat Assessment (GRIHA) rating system. This framework serves as a tool for assessing the environmental performance of buildings. Furthermore, the government has introduced incentives, such as tax breaks, to incentivize developers who integrate sustainable design principles into their projects.

As the industry looks into the future, investors and developers are increasingly recognizing the importance of sustainable development as a strategic investment. This enduring trend not only contributes to a more sustainable and resilient built environment but also reflects a forward-thinking approach that aligns with the values and expectations of today's conscious consumers and investors. With the government actively promoting green initiatives and an increasing awareness among developers and investors, there is optimism for a sustainable future in the country's real estate industry.
